In case, any team member is covered under the above act, he/ she obtain the prior permission from Ministry of Home Affairs before their departure to USA.
- 3. As regards foreign exchange required for above participation on the federation is requested to approach authorized dealers for getting the foreign exchange in view of RBI circular No. 41 A.D (M.A. Series) dated 25.1.97.
- Such of the team member who might be Central Government Servants are to be treated as on duty (Which includes deputation abroad) in respect of the participation by the Departure / Office in which they are employed in teams of Department.
- 5. Personnel & Training O.M. No. 6/1/85-Est. (Pay-1) dated 30.1.1989. The Federation should inform their employing Department/ Office accordingly.
- 6. It is requested that Indian High Commission/ Embassy in USA and organizers of the event may please be informed by fax/email of the travel plans and itinerary of the team for participation in the above event. The team members may be advised to call on the Mission for exchange of view.
- 7. A report on the visit of the team along with its performance / achievement in the above event may please be sent to this Ministry/SAI within 7 days of the return of the team to India along with some action photographs, if possible.
- 8. Before departure, a report on dope test of the team members may please be obtained from DG, NADA New Delhi.
- 9. Travel Sector : Delhi/Hometown to USA and back.
