Such of the team – member who might be Central Government Servants are to be treated as on duty (Which include deputation abroad) in respect of the participation by the Departure / Office in which they are employed in teams of Department Personnel & Training O.M. No. 6/1/85-Est. (Pay-1) dated 30.1.1989 **Indian Wushu Team,(Manager) Mr.Ratnesh Singh Thakur** should inform their employing Department/ Office accordingly.
4. It is requested that Indian High Commission/ Embassy in **Brunei** and organizers of the event may please be informed of the travel plans and itinerary of the delegation for participation in above event. The team members may be advised to call on the Mission for exchange of views.
5. A report on the visit of the team along with its **performance/achievement** in the above Event may please be sent to TEAMS Division, SAI within 7 days of the return of the team to India along with **some action photographs**, if possible.
6. Before departure of the team, **Mr.Ratnesh Singh Thakur** may please have the report of Dope Test of members of the team from NADA, If Necessary.
7. Concern Regional Centers are requested to relieve Mr. **Mr.Ratnesh Singh Thakur** (Wushu Coach,NCOE Patiala) & Mr.Sumit Kumar(NCOE Wushu coach,Imphal) for the said tournament.
8. Physiotherapy Consumable equipment will be procured by the SAI Coach (Mr.Ratnesh Singh Thakur) for the said competition and the same will be entered into a stock register at NS NIS Patiala &accordingly Bills will be settled to the SAI Head office for the final settlement.
